Customer Background

Client is the fifth largest dairy company in the world. It is a co-operative owned by more than 12,500 dairy farmers. It combines traditional craftsmanship and world-class technologies to ensure its products remain closer to nature, from farm to fridge. The subsidiary company in the Middle East is a wholly owned subsidiary and has been in the region for over 60 years.

Business Case

Client was earlier working on Microsoft Dynamics Navision. Some of the issues with the previous system were:

- The numerous legacy IT systems had functional limitations
- Accuracy of data was inconsistent due to huge volumesacross multiple different applications
- Complex production routing operations including Cleaning In Process (CIP) and Incubation Time

The requirements from the client for the new system were:

- Simple user friendly application with performance, security, scalability & upgradability
- Integrated functions for finance, supply chain, production operations & planning management
- Vendor calendar based long term purchase planning for longer lead time products
- Management of single logistics operations for 2 legal entities
- Integration with Infor WMS systems and retail sales application (dMAS)

Challenges

This has been the first implementation of Microsoft Dynamics 365 from GITL. The team faced lot of challenges to install this version at the customer site, which were successfully resolved by collaborating with the Microsoft product team.
